If you are seeking for media and press coverage credentials on behalf of an organization, media outlet, or publication, you confirm that you have the right and authority to enter into this agreement on behalf of that entity.

In consideration of being granted media and press coverage credentials (the “**Credentials**”) for access to FestAfrica 2016 (the “**Event**”), the undersigned individual (“**you**”) on behalf of herself/himself and the organization, media outlet, or publication who you represent (the “**Outlet**”) hereby enters into this agreement (this “**Media Coverage Agreement**”) with the promoters of the Event (the “**Host**”).

1. **Credentials.** The Host will provide Credentials necessary for you to access the Event for the purposes of media, press, and/or editorial coverage of the Event. Time, area, and scope of access will be at the sole and absolute discretion of the Host. The Credentials are non-transferrable and you agree not to sell, donate or transfer it to any third party before, during, or after its use at the Event. The Credentials may be revoked at any time by the Host with or without cause. The Host shall have no liability to you or the Outlet should the Credentials be revoked.
2. **Use of Media.** In relation to all still photography, video footage and audio recordings captured relating to the Event (“**Media**”), you agree to the following: a. When publishing, distributing,

displaying or otherwise using Media, you will (i) refer to Fest Africa and the Host and (ii) provide a working Internet link to or otherwise display the URL for Fest Africa (i.e.

<http://www.festafrica.com>). b. You will not use, publish, distribute or display Media for commercial or retail purposes. c. You will not use, publish, distribute or display Media except for purposes of (i) media, press, and/or editorial coverage of the Event, (ii) use rights under the First Amendment, or (iii) as otherwise specified herein. d. You will provide the Host [info.festafrica@gmail.com] with a copy of or an Internet link to any article, post, or editorial content containing the Media.

3. ***Intellectual property.*** Nothing in this Media Coverage Agreement authorizes or allows you or the Outlet to violate any of the trademarks, copyrights or other intellectual proprietary rights of the Host or relating to the Event.
4. ***Authority.*** If you are executing this Media Coverage Agreement on behalf of the Outlet, you confirm that you have the right and authority to enter into this Media Coverage Agreement on the Outlet's behalf. You agree to be fully responsible for any breach of this Media Coverage Agreement by the Outlet or any employee, agent, or representative of the Outlet.
5. ***Law.*** This Media Coverage Agreement will be governed by and construed in accordance with the laws of Washington D.C.
6. ***Term.*** The obligations contained in this Media Coverage Agreement hereunder will automatically terminate after three (3) years from the date above.
